## **WATER SERVICE INTERRUPTION AND PRECAUTIONARY DRINKING WATER ADVISORY**

Please be advised that water service to a portion of SE Sylvan and SE Oriole Street, as shown in red on the attached map, was interrupted on Monday, February 2, 2026 for an emergency repair to the water distribution system.

**CUSTOMERS THAT DID NOT RECEIVE A NOTICE ARE NOT AFFECTED BY  
THE OUTAGE OR THE PRECAUTIONARY ADVISORY**

The advisory will remain in effect until the Clay County Utility Authority conducts a bacteriological survey of your public drinking water supply. **Two consecutive days of satisfactory bacteriological samples are required before this advisory can be lifted.**

**The Authority will post a notice on your door and update our website when the FDEP lifts the “Drinking Water Advisory”.**

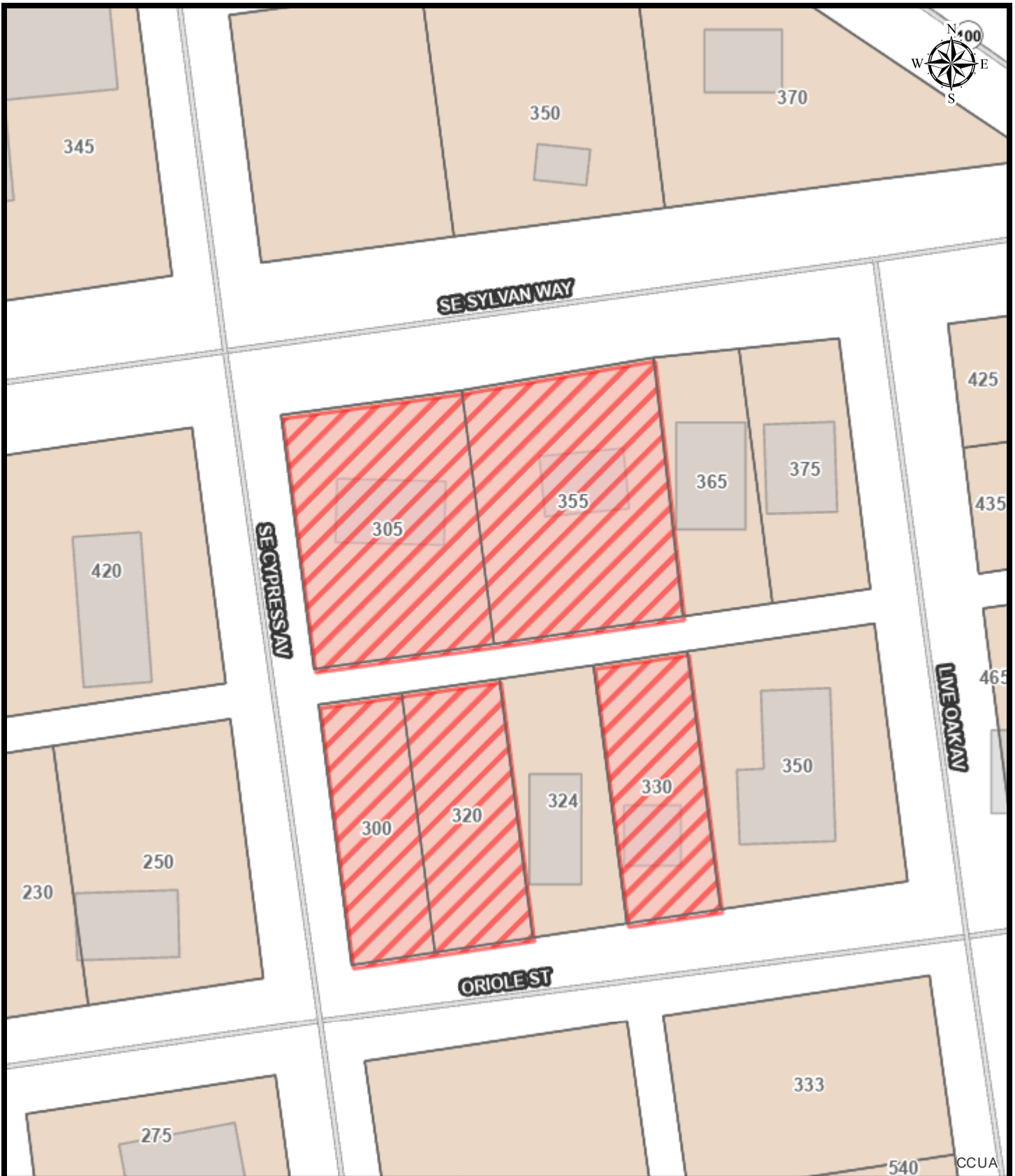
**While the water is off**, we recommend that you turn off all appliances that automatically draw water - including but not limited to washing machines, dishwashers, ice makers, water heaters, water softeners.

Service will be restored once our technicians complete the repair and have flushed the water lines and measured disinfection levels to ensure water quality. Once this occurs, we suggest you allow water to run in your kitchen and bathrooms for several minutes to remove any sediment or air may have entered the system. **If there is air in your system the water will appear milky, this is no cause for alarm, please flush the line until the air has been removed.**

### **- IMPORTANT -**

**As an extra level of care following such an interruption, the Florida Department of Environmental Protection (FDEP) requires Clay County Utility Authority to notify you that you will be under a Drinking Water Advisory. As a precautionary measure and until further notice, you are advised that water used for human consumption (drinking and food preparation) must be BOILED for at least three (3) minutes.**
